## VENDOR AGREEMENT

### I. Formation

The undersigned hereby form a Vendor Agreement in, and in accordance with the laws of, the State of Arizona.

### II. Name

The name of the Partnership shall be 2018 Barber & Salon Hair & Beauty Competition.

### III. Term

### IV. Purpose

The purpose of the Vendor Agreement is to secure vendor space for the 2018 Barber & Salon Hair & Beauty Competition. Vendor agreement will minimize "no-shows", cancellations, or failure to pay.

### V. Communications

Both parties agree to work together for the success of the event. Periodic follow up will take place monthly between vendor and PPI to ensure knowledge passthrough, changes in venue, time and date of event, or any subsequent knowledge that may hinder success of the 2018 Barber & Salon Hair & Beauty Competition.

### VI. Costs/Fees

Vendors will need to make a security deposit of 20% at sign up and pay in full two weeks prior to event. Vendors may also make optional full payment of vendor spot to secure 1st placement of space. The full amount of \$\_\_\_\_\_. Vendor pricing below:

5X5 Vendor Table or Space **\$200**; Includes round table to display products or services, four comfortable chairs, one lunch, four non-alcoholic drinks and two cocktails.

10X10 Vendor Space **\$400**; Includes two big tables, four comfortable chairs, lunch and dinner for two, with six non-alcoholic drinks, four cocktails.

20X20 Vendor Space **\$800**; Includes two big tables in vendor area, one table by the main stage, twelve comfortable chairs, lunch and dinner for four, with eight non-alcoholic drinks & eight cocktails.

**VII. Valuation of the Vendor Agreement**

The current value of vendor commitments directly reflects the success of the fundraising event. We look to establish commitments and lock in placement of you, your company to maximize lead generation potential as well as bring overall value of the event. This will in turn give vendors who sign and commit to 2018 Barber & Salon Hair & Beauty Competition the best opportunity to generate revenue.

**X. No Compensation**

No additional compensation other than the full price of the vendor selection.

**XI. Termination of Partnership**

The Vendor Agreement may be terminated no later than January 18, 2018. Written notice of a meeting where termination of the agreement is to be considered shall include a specific reference to this matter. Written notice of the decision to terminate the agreement shall be given to PPI Point of Contact. Security deposit is forfeited if after February 4, 2018 if vendor fails to pay in full the remaining deposit.

**XII. Death or Incapacity of a Vendor**

In the event of the death or incapacity of a Partner (or the death or incapacity of the grantor and sole trustee of a revocable living trust), receipt of notice shall be treated as a notice of full withdrawal with security deposit being returned.

This Agreement shall be binding upon the respective heirs, executors, administrators, and personal representatives of the PPI and Vendor.
